

List of documents to be produced at the time of Interview & Admission:

Students must bring with them all the ORIGINAL copies/relevant documents, including mark sheets for all semesters. They should bring two set of self-attested photocopied documents with them for the purpose of submission with the printed admission form.

- 1. Two passport size recent photographs
- 2. Statement of marks of the **qualifying** exam (LLB/BA LL B). (Original Mark sheets of **ALL** semesters are required.)
 - 1. SSC or Xth or equivalent certificate.
 - 2. HSC or XII th or equivalent certificate
 - 3. Graduation mark sheet. (e.g. B.A., B.Com., B.Sc. etc.)(If applicable)
 - 4. Passing Certificate of BA LL B or LL B examination
 - 5. Transfer Certificate of the College last attended.
 - 6. Migration Certificate of the University or College or Board or School attended, if it is affiliated to any university other that Savitribai Phule Pune University (If you do not have it at the time of interview, you must undertake to submit it within fifteen days from the date of admission.)
 - 7. If you seek a seat in the reserved categories:
 - 1. Caste certificate and Caste validity certificate issued by competent authority
 - 2. Candidates belonging to NT, VJNT, OBC,SEBC,SBC shall produce the Non Creamy layer certificate should be valid till 31st March, 2026. Students who do not possess valid non creamy layer certificate at the time of interview/admission will not be considered for admission under the respective reserved category.
 - 8. Domicile certificate / Birth Certificate or LC stating the place of birth for the students within the state of Maharashtra.
 - 9. Gap Certificate, if required, and if not produced with the application form, must be submitted at the time of interview.

Fees

- 1. The student must pay the fees immediately after the interview. Last date to accept the fees is 17th July 2025. The admission will be confirmed only after payment of fees.
- 2. Payment of fees can be made in online/offline mode immediately after the interview.
