2. **University Identity Card** and a **colored copy of the Passport** (front and back page) along with the original passport (valid for at least six months).
3. **Recent Passport Size Photographs** (Five copies, 45 x 35 mm, **background of the photo should be light grey**, bareheaded).
4. **No Objection Certificate (NOC)** from the University for his / her participation in WUG-2025 (Germany).



Annexure-I

GUIDELINES FOR THE SELECTION OF INDIAN NATIONAL UNIVERSITY TEAMS/ATHLETES for WUG-2025

FISU GENERAL REGULATIONS FOR PARTICIPATION

I. General Eligibility

The athletes:

- be at least 18 and no older than 25 years of age on the 31st December of the event for 2025, athletes must be born between 01-01-2000 and 31-12-2007.
- Athletes participating in FISU sports event must represent the same country as in their respective international federation events.
- The athletes must be the bonafide student of their respective University or former students of the universities who have obtained their academic degree or diploma in the calendar year preceding the event.

II. Game Specific Eligibility of Players/Teams for participation in Selection Trails of the Indian Universities Team (Men & Women).

Archery

- I. Top 8 (eight) athletes of the All India Inter University Games Archery held at KIIT University, Bhubaneswar.
Or
- II. Top 8 (eight) athletes of the Khelo India University Games Archery held at Meghalaya and Khelo India Youth Games 2024 (Tamil Nadu).
Or
- III. Players who were top 8 (eight) in Senior or Junior National Championship nationals of current session 2024-25.
Or
- IV. An international player who has represented India in Senior or Junior categories of last 2 (Two) years (from 1st July 2023 onward).
Or
- V. Players, who have extraordinary international sports credentials or top scores/ results at Indian national trials of concerned sports but not covered under above mentioned categories, may also apply for the selection trials. After duly scrutinizing their performance by the expert committee of AIU, the eligible players will be informed accordingly.

- VI. It may please be noted that the players of above-mentioned categories for selection trials is to be recommended by the Director Sports/Head of the Sports Department/DSW of concerned Universities.

III. **General Guidelines for Selection.**

- Merit will be based on Individual performance and not the Team performances.
- In weighing sports, the weighing will be done as per rule, i.e. one day before the event at 4:00 pm (with hard copies of all documents).
- The decision of the selection committee will be final and binding.
- Boarding and Lodging shall be provided by the host/organizing University on payment basis at the competition venue.
- After the selection trial, a national training camp will be organized allocated by AIU to a member University and the information of the same will be conveyed to the respective universities in due course of time.
- The committee has the right to select the best athlete in the country, in case the policy is silent with prior approval from AIU.

IV. **Important Note :**

- FISU has not imposed any restrictions on athletes employed in either the government or private sector from participating in the selection trials, provided they meet all other eligibility criteria.
